The deadline for School Choice is **March 1**. A lottery will be conducted to fill available school choice slots for the coming school year the first week of March. Applicants will be informed by their home high school regarding their status by April 1. Applications received after March 1 may be considered on a case-by- case basis, depending on slots still available and individual school choice procedures.

Please note: Only a limited number of school choice slots are available each year. Every school has a different number of slots depending on the size of the school and limits established in congruence with VT Law.

Home School Instructions

- o When the School Choice application has been approved by the home school Principal, fax a copy to the choice school as soon as possible.
- o Cooperating principals make "good standing" determination.
- o Once the "out" lottery has been completed, the principal of the student's home school will notify the family of their selection into the choice program.
- o If a student does not make it into the choice program, the family will be notified in writing and will be given his/her ranking from the lottery.
- o The principal will notify the choice school of the acceptance or rejection of the choice program.

Choice School Instructions

- o Once the application is received and approved by the choice school Principal, please fax a copy back to the home school for their records.
- o Assure that your district is able to enroll the student in line with regard to "caps" or agreement.
- o Contact parent/guardian of applicant to set up enrollment appointment.
- o Request records from the home school Guidance Department.
